# **Privacy Policy**

#### Collection

We collect the following personal data for contact with regard to our services, statutory obligation, and for human resourcing:

- Name
- Address (either workplace or personal)
- Contact details (phone, email)
- For employees; date of birth, bank account details, social security and tax information, professional references, workplace medical data, performance and appraisal data.

### **Processing**

We will process your data in accordance with Data Protection (Jersey) Law 2018.

We will endeavour to keep your data accurate and up to date and only hold it for as long as necessary.

We will not pass your data to anyone outside our organisation, other than those who process information on our behalf (please see table below), or because of legal or statutory requirement and only after we have ensured sufficient steps have been taken by the recipient to protect your data

We will not publicise any of your data unless this is required to carry out a statutory function. We will not disclose any information that you provide 'in confidence', to anyone else without your permission, except if required by law, or where we have good reason to believe failing would put someone at risk. You will be informed unless there is exceptional reason not to do so.
